2020 PAPS Constitution & By-Laws

By-law Change recommendations

PRESENT LANGUAGE

Article II - Meetings & Voting

SECTION 1 - CLUB MEETING

Meeting of the Club shall be held within the greater Seattle area on every odd month at such date, place, and hour as may be designated by the Board of Directors. Written notice of each such meeting shall be mailed by the Secretary at least ten days prior to the day of the meeting. The quorum for such a meeting shall be 20% of the membership in good standing.

SECTION 5 - VOTING:

Each member in good standing whose dues are paid for the current year shall be entitled to one vote at any meeting of the club at which he is present. Proxy voting will not be permitted at any club meeting or election.

Article VII – Amendments

SECTION 2 -The Constitution and By-Laws may be amended by a 2/3 vote of the members present and voting at any regular or special meeting called for the purpose, provided the proposed amendments have been included in the notice of the meeting and mailed to each member at least two weeks prior to the date of the meeting.

PROPOSED LANGUAGE

Article II – Meeting and Voting

SECTION 1 - CLUB MEETING

Meeting of the Club shall be held within the greater Seattle area on every odd month at such date, place, and hour as may be designated by the Board of Directors *and may be held electronically by use of teleconferencing or virtual meetings*. Written notice of each such meeting shall be mailed by the Secretary at least ten days prior to the day of the meeting. The quorum for such a meeting shall be 20% of the membership in good standing.

SECTION 5 – VOTING:

Each Member in good standing whose dues are paid for the current year shall be entitled to one vote on any motion at any meeting of the club for which they are present. *Mail voting will only be used for Judges Selection. All motions at standing meetings will require a quorum to be present for voting.*

Article VII – Amendments

SECTION 2 -The Constitution and By-Laws may be amended by a 2/3 vote of the members present and voting at any regular or special meeting or *by mail* called for the purpose, provided the proposed amendments have been included in the notice of the meeting and mailed to each member at least two weeks prior to the date of the meeting.
