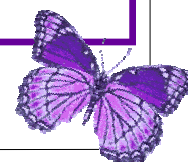

On a serious note, I am going to propose a motion to revise Standing Resolution #1 to be made at our July meeting to give some opportunity for a Show Chair to at least be able to show in a Non-Regular un-pointable class (except Veterans since they can move up to Breed competition). Examples of Non-Regular would be Brace, Multi-Generational, Parade of Titleholders, etc...

We talk about this topic every year and we know many of you refuse because you want to be able to show your dogs. Well, so do Show Chairs. While this may not be the optimum solution it would give Show Chairs some opportunity to showcase their dog in a non-competitive manner.

Here's how the present SR is written now –

SR #1

Revised: March 2019

The Conformation Show Chairperson and anyone living in their household will not enter nor exhibit any dog at this show. Any dog co-owned by the Show Chair may be shown as long as it is exhibited by the co-owner. An Assistant Show Chairperson may exhibit any dog owned, or co-owned as long as they have no contact with any Judge for this show. A statement to this effect must appear in the premium list.

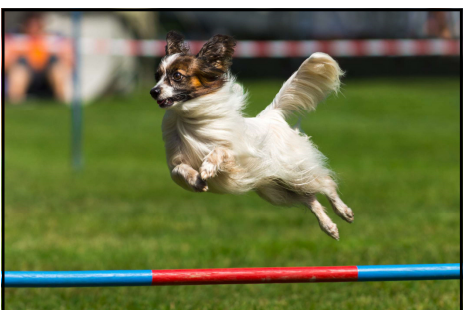
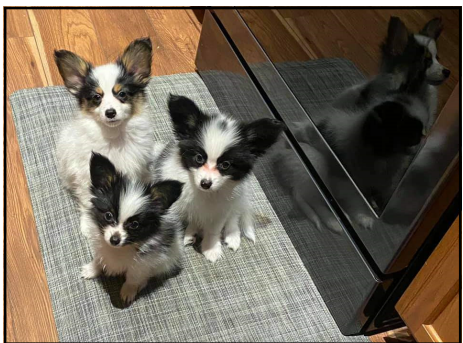
Revised: March 2019

The Conformation Show Chairperson and anyone living in their household will not enter nor exhibit any dog at this show. Any dog co-owned by the Show Chair may be shown as long as it is exhibited by the co-owner. An Assistant Show Chairperson may exhibit any dog owned, or co-owned as long as they have no contact with any Judge for this show. **Show Chair may enter Non-Regular classes such as Brace, Multi -Generational, Parade of Titleholder or similar where their entries will not be in competition for points or Breed Titles.**

A statement to this effect must appear in the premium list.
