ARTICLES OF INCORPORATION

SECRETARY OF STATE
STATE OF WASHINGTON

The undersigned, for the purpose of forming a corporation under the nonprofit laws of the State of Washington, RCW 24.03, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

PAPILLON ASSOCIATION OF PUGET SOUND

ARTICLE II

The term of existence shall be a) XXXX perpetual

ARTICLE III

The purposes for which the corporation is organized are as follows:

- A. To encourage & promote the breeding of purebred Papillons and to do all possible to bring their natural qualities to perfection.
- B. To urge members & breeders to accept the standard of the breed as approved by the AKC as the only standard of excellence by which Papillons shall be judged.
- C. To do all in its power to protect and advance the interest of the breed by encouraging sportsmanlike competition at dog shows and obedience trials.
